

SINGLES INTERNATIONAL CHAPTER COMMUNICATIONS

Your Singles International Chapter Executive believes that communicating with members is very important. Because of this, we use a number of tools to keep members informed.

Until recently, this newsletter, Scuttlebutt, was the primary communications tool.

Also, very important is the chapter website https://www.si-fmca.com which was recently completely redone. (Make sure to check it out)

A few years ago our Facebook page was added as an additional tool for quick communication.

Occasionally important breaking news was dispatched to members by email.

This latter communications method is now compromised due to some legal hurdles around the U.S. Federal CAN-SPAM act. (See our President's column on page 2 and details near the bottom of this page and on the following page.)

The best way for members to keep up to date with what is happening with the chapter is to frequently check the web site.

Those of you who are on Facebook can also read about breaking news on the Singles International page. If you do not see this page regularly in your Facebook feed you can access it by clicking on a link. You will find the link on the website and also on page 3 in the digital version of Scuttlebutt. If the links do not work, you can type the following into your browser: https://facebook.com/groups/240021600745273

Don't worry, Scuttlebutt will still be published bi-monthly. If you have blocked emails from FMCA you may not get it in that way but you can always consult it on the website where it should appear even before the emails are sent out.

Please give us feedback on how you like to receive communications and what you like to hear about. Contact anyone listed on page 3.

The following is an excerpt from a communication sent by Chapter Services Dept at the FMCA National Office to chapter officers on Oct 4, 2022..

The ability for chapters and areas to communicate with its members is of vital importance

to FMCA. For the distribution of electronic communications (emails), we need your help to

assure FMCA remains compliant with the CAN-SPAM Act, a federal law established in

2003. This will allow chapters and areas to continue communicating with members through

electronic means and protect the association from legal challenges.

While the CAN-SPAM Act has been around for nearly 20 years, the need for FMCA chapters and areas to be compliant has become increasingly important. More and more FMCA chapters and areas use electronic means, specifically emails, to communicate with its members. Also, the FMCA national office has received complaints and concerns from members about receiving unsolicited emails from areas and chapters. As stated before, if a recipient of unsolicited email from FMCA or any of its affiliated entities was to file a complaint with the FTC, the fines could be very costly to the association.

With these facts, FMCA, including its chapters and areas, must comply with the CAN-SPAM Act. FMCA attorneys have noted that this law applies even to the promotion of chapter and area activities. To assure chapters and areas remain compliant, there are two electronic communication options:

- 1. The chapter/area can compose a message, send it to the national office, and tell us who should receive the message. FMCA will send this message on the group's behalf at no cost to the chapter or area. To find out more about this process or to submit a request for this service, please email chapters@fmca.com.
- 2. The chapter/area can purchase an email deployment system that will bring the group into compliance. The system must be CAN-SPAM compliant and could result in additional costs to the chapter or area.

This is being done to protect FMCA, comply with federal law, and to ensure members receive communications from chapters and areas in a compliant manner.

PARKING AREA DESCRIPTIONS

General Parking – Use of factory-installed generator permitted from 6 a.m. to 11 p.m.

Electric Parking – Electric (30-amp or 50-amp) will be available at your parking space when you arrive.

Full Generator – Factory-installed generator use permitted 24 hours a day.

No Generator - Generator use not permitted. Limited.

External Generator – Use of a portable generator placed outside of the RV permitted from 6 a.m. to 11 p.m.

External Full Generator – Use of a portable generator placed outside of the RV permitted 24 hours a day.

Disabled Parking – The dedicated Disabled Lot will include 30-amp and 50-amp. Those who register for other types of service will be parked as close as possible to the activity areas.

Passport And Public Gate Car Parking – No overnight parking on event site property. Passport and Public Gate RVs cannot be accommodated at the grounds. The Passport and Public Gate car parking lot will be open from 8 a.m. to 10 p.m., March 14 through 18, 2023.

FMCA PAYMENT PLAN

The FMCA Payment Plan is available for those who register by credit card. This plan allows registrants to pay half of the total registration cost upon initial registration, with the balance charged at a later date. For the Perry convention, the remaining balance will be charged on January 16, 2023.

MOBILITY CART/GOLF CART INSURANCE & USE

Attendees must have valid insurance on personal mobility carts and/or golf carts. All golf carts must have operating headlights if used before sunrise or after sunset. The speed limit for all vehicles in the activity areas is 5 mph.

VOLUNTEERS

Volunteers will be parked in the volunteer parking area, and electric (if purchased) will be available at your site on the day indicated on your "Date of Entry" card. If you are a volunteer and wish to park in another parking area, FMCA does not guarantee that the electricity in that lot will be available on the date you arrive.

MAILING AND PARKING PROCEDURES FOR ALL PARKING AREAS

All registered guests must display the parking and "Date of Entry" credentials in the motorhome or towing vehicle windshield in order to facilitate your entry onto the grounds.

FMCA will begin mailing the credentials as soon as January 25, 2023. Please provide a valid mailing address or you can choose to have your packet held at Will Call. Registrations received after February 24, 2023, will automatically be held at Will Call.

Those who choose to have their credentials held at Will Call will be emailed directions, pickup instructions, and a Will Call placard to be printed and affixed to the windshield. Will Call hours will be 8 a.m. to 5 p.m., Sunday, March 12, through Wednesday, March 15, in the Welcome Area.

WELCOME AREA

The Welcome Area will be open 8 a.m. to 5 p.m. Sunday, March 12, through Wednesday, March 15.

PARKING

Parking will be located at the Georgia National Fairgrounds. Each RV will be parked with the assistance of a parking team member, no exceptions. Parking hours will be from 8 a.m. to 5 p.m. All parking will be at the discretion of the parkers.

Registered family members will be assigned a parking date of Monday, Tuesday, or Wednesday, March 13, 14, or 15, 2023. Families are requested to arrive on the date stated on their "Date of Entry" card. When registering, please advise if you cannot arrive on one of the assigned parking dates.

PARKING TOGETHER

If you would like to park with family or friends, you must register for the same type of parking and have the same "Date of Entry." You must arrive together or wait in the Welcome Area until all parties have arrived to be parked.

CARAVANS

Groups of 10 or more RVs wishing to park together must register as a caravan with FMCA's Events Department by February 10, 2023. EARLY ARRIVALS

If you arrive prior to your "Date of Entry," dry camping will be available in the Welcome Area starting Sunday, March 12, at no charge. If you arrive early and would like to be parked in your final parking site (during scheduled parking hours), you will pay an additional \$40 per night (payable on-site; cash or check).
